


#### Figure 6.9. CCC indicator framework for the agriculture sector



### Changing Climate, Changing Diets Pathways to Lower Meat Consumption





- A. Public awareness raising and information campaigns
- B. Public procurement- e.g. vegetarian/ vegan school dinners
- C. Price manipulation- e.g. a meat tax
